HIGHWAY 417 FULL CLOSURE & PRESTON STREET FULL CLOSURE PRESTON STREET BRIDGE REPLACEMENT

Closure of Preston Street, Highway 417 east and west bound lanes, Maitland Avenue eastbound on-ramp, Carling Avenue eastbound on-ramp, Parkdale Avenue eastbound on-ramp (ongoing), O'Connor Street westbound on-ramp, Lyon Street westbound on-ramp (ongoing), Bronson Avenue westbound on-ramp, Rochester Street westbound on-ramp (ongoing), and Parkdale Avenue westbound on-ramp.

Kiewit Dufferin Midtown Partnership (KDMP) has been retained by the Ontario Ministry of Transportation to replace the Preston Street bridge on Highway 417 / Ottawa Queensway. To facilitate this work, KDMP will be required to implement closures on Highway 417 and various adjacent city streets. KDMP intends to keep an open communication channel with all residents and affected agencies. To that end, please see the below information providing further details regarding closures and the affected area.

WHEN:

HWY 417 east and west bound lanes between Carling Avenue and Metcalfe Street - (full closure to vehicular traffic – follow detour shown in Figure 1)

Anticipated Start Date: July 25, 2024 @ 8:00PM Anticipated End Date: July 29, 2024 @ 6:00AM

HWY 417 eastbound on-ramps (full closure to vehicular traffic – follow detour shown in figure 1)

- Maitland Avenue on-ramp
- Carling Avenue on-ramp
- Parkdale Avenue on-ramp (ongoing to reopen in August 2024)

Anticipated Start Date: July 25, 2024 @ 8:00PM Anticipated End Date: July 29, 2024 @ 6:00AM

HWY 417 westbound on-ramps (full closure to vehicular traffic – follow detour shown in Figure 1)

- O'Connor Street on-ramp
- Lyon Street on-ramp (ongoing to reopen in fall 2025)
- Bronson Avenue on-ramp
- Rochester Street on-ramp (ongoing to reopen in October 2024)
- Parkdale Avenue on-ramp



Anticipated Start Date: July 25, 2024 @ 8:00PM Anticipated End Date: July 29, 2024 @ 6:00AM




Figure 2 Preston Street Closure Vehicle Detour Route






Figure 3 Preston Street Closure Pedestrian and Cyclist Detour Route

Preston Street (full closure to vehicular, cycling, and pedestrian traffic – follow detours shown in figure 2 & figure 3)

Between St. Anthony Street and Young Street

Anticipated Start Date: July 17, 2024 @ 12:01AM Anticipated End Date: August 6, 2024 @ 11:59PM

Between Louisa Street and Young Street

Anticipated Start Date: July 25, 2024 @ 8:00PM Anticipated End Date: July 29, 2024 @ 6:00AM

WHY: To facilitate the access for construction including but not limited to, replacement of the existing

bridge on Highway 417 as well as repairs to the existing infrastructure and tie-in points.

WHERE: Construction Activities will be taking place in the following locations:

- HWY 417 eastbound lanes Carling Ave to Metcalfe Street
- HWY 417 westbound lanes Metcalfe Street to Carling Avenue


